FINAL JUDGMENT

This matter came for trial on November 13-16, 2023 before the Honorable Judge Robert L. Wyatt. Present were:

Lawrence E. Marino and Daniel J. Phillips for Plaintiff, LAKE CHARLES HARBOR AND TERMINAL DISTRICT; and

Randall A. Smith, L. Tiffany Hawkins, and Stephen D. Polito for Defendants, FRANCIS E. ROTHCHILD, JR. AS INDEPENDENT EXECUTOR FOR THE ESTATE OF DOROTHY BARBE ROTHCHILD and FRANCIS E. ROTHCHILD, JR. AS INDEPENDENT EXECUTOR FOR THE ESTATE OF DON PAUL BARBE, M.D.

Considering the law, the evidence, the pleadings, and the arguments of counsel:

IT IS ORDERED, ADJUDGED AND DECREED that there be judgment in favor of Defendants and against Plaintiff in the amount of \$5,595,472.00, subject to a credit in the total amount of \$1,526,949.00 previously deposited by Plaintiff into the registry of the 14th Judicial District Court for the Parish of Calcasieu, State of Louisiana.


IT IS FURTHER HEREBY ORDERED, ADJUDGED AND DECREED that there be judgment in favor of Defendants and against Plaintiff for judicial interest on the sum of \$4,068,523.00 or any part thereof so long as it remains unpaid, from May 27, 2022 until such time as such amount is deposited by Plaintiff into the registry of the 14th Judicial District Court for the Parish of Calcasieu, State of Louisiana, which is stipulated to be \$317,345.00 through November 30, 2023 and accruing at an additional \$814.64 per day thereafter.

IT IS FURTHER HEREBY ORDERED, ADJUDGED AND DECREED that there be judgment in favor of Defendants and against Plaintiff for attorney fees and expert witness fees fixed in the amount of \$700,000.00.

IT IS FURTHER HEREBY ORDERED, ADJUDGED AND DECREED that Plaintiff deposit into the registry of this Court, for the use and benefit of Defendants, as the persons entitled thereto, the sum of \$5,085,868.00.

IT IS FURTHER HEREBY ORDERED, ADJUDGED AND DECREED that Plaintiff pay all court costs in this proceeding for which it may be legally assessable.
